# Why are we considering 20mph?

Edinburgh's streets are shared by many people and types of transport. We want to make our streets safer and more pleasant for all, especially the most vulnerable in our communities. High traffic speeds can often put people off walking and cycling and can increase the severity of accidents. Research shows that the number and severity of casualties is reduced if traffic is moving at 20mph rather than 30mph or faster.

Following a successful pilot of a 20mph speed limit area in South Edinburgh and strong support demonstrated through public consultations and attitude surveys, the Council's Transport and Environment Committee approved a draft network of 20, 30 and 40mph roads as a basis for consultation and authorised a public consultation on extending the 20mph speed limits to many roads in the city.

# What is proposed?

The Council is proposing 20mph speed limits for a large area of central Edinburgh, all main shopping streets and residential streets throughout the city. Streets with a high level of pedestrians and cyclists are also included.
